COMPETENCY TRAINING FOR GREEN BUILDING CERTIFICATION IN MELAKA



BACKGROUND

Melaka city state is one of the 28 cities selected from 11 countries to participate in the Global Integrated Approach Pilot Program for Sustainable Cities under Sustainable City Development in Malaysia Project (2017-2021). This program, which is funded by the Global Environment Facility (GEF) is intended to promote an integrated approach to urban planning and management.

The Project is currently being implemented by Melaka Perbadanan Teknologi Hijau Melaka (PTHM) in collaboration with the Ministry of Housing and Local Government of Malaysia (KPKT) (National Lead Ministry), Malaysian Industry-Government Group for High Technology (MIGHT) (National Lead Agency), Local Government Department, Standards Malaysia and Malaysia Green Technology Corporation (MGTC).

Melaka State Government has introduced its own green building rating tools namely Melaka Green Seal since February 2012. This tool has been developed by Perbadanan Teknologi Hijau Melaka (PTHM) and Melaka Green Development Organisation (MGDO). Melaka Green Seal is designed with a holistic approach to include basic requirements in MS 1525, UBBL and local authority rules and regulations.

It is Melaka State Government intention to enhance the capacity of Melaka Green Seal building assessors on technical knowledge, guidelines and regulations and increase the awareness programs to the public.

BENEFITS

Candidates who passed the competency training will be:

- Appointed as PTHM Assessor
- Given allowance when conducting site evaluations
- Appointed as technical advisor for Melaka Green Seal development.

OBJECTIVES

At the end of this training the candidates are expected to be able to:

- Explain the basic requirements of Melaka Green Seal green building rating tools.
- Assess building in Melaka based on Melaka Green Seal for certification of green building.
- Share the knowledge in training individuals on Melaka Green Seal assessment.
